**PUBLIC NOTICE**  
**GENERAL ELECTION – NOVEMBER 1, 2009**  
**REVISION OF MUNICIPAL LIST OF ELECTORS**

**TO THE ELECTORS OF THE MUNICIPALITY OF HAMPSTEAD**

**PUBLIC NOTICE** is hereby given by the undersigned Returning Officer, that:

1. The list of electors will be filed with the office of the Returning Officer on October 2, 2009 and will be revised starting on October 14, 2009.
2. To be an elector and to qualify for entry on the municipal list of electors, a person must be of legal age on November 1, 2009 and, on September 1, 2009
  - be a Canadian citizen;
  - not be under curatorship;
  - not have been convicted of an offence that is a corrupt electoral practice;

**and** meet one of the following conditions:

- be domiciled in the territory of the municipality on September 1, 2009 and since at least March 1, 2009 in Quebec.

**or**

- since at least September 1, 2008, be either:
  - the **sole owner of an immovable** in the territory of the municipality, provided that he is not domiciled in the territory of the municipality and have submitted a written application for entry on the municipal list of electors with the municipality and/or the Board of Revisors, **or**
  - the **sole occupant of a business establishment** in the territory of the municipality provided that he is not the owner of an immovable elsewhere in the territory of the municipality, is not domiciled in the territory of the municipality and have submitted a written application for entry on the municipal list of electors with the municipality and/or the Board of Revisors.

NOTE: the sole owner of several immovables or the sole occupant of several business establishments must register at the address of the immovable or the business establishment which has the greatest property or rental value.
- or**
- the **undivided co-owner of an immovable or co-occupant of a business establishment** in the territory of the municipality provided that he has been designated by means of a power of attorney signed by the majority of co-owners or co-occupants who are electors of the municipality on September 1, 2009.
- A person who is already entitled to be entered on the list of electors in his capacity as a domiciled person, owner of an immovable or occupant of a business establishment cannot be designated a co-owner. A person who already is entitled to be entered on the list of electors in his capacity as a domiciled person, sole owner of an immovable, sole occupant of a business establishment or designated co-owner of an immovable cannot be designated co-occupant.

3. In the case of an application for entry of a domiciled person on the territory of the municipality, the applicant must indicate the former address of the domicile of the person whose entry is requested and submit two documents, one of which indicated the name and date of birth of the person concerned, and the other the name and the address of the domicile of the person concerned.
4. The list of electors may be consulted and applications for entry (domiciled electors only), striking off or correction must be submitted on the following dates and times at the office of the Board of Revision located at the following address:
